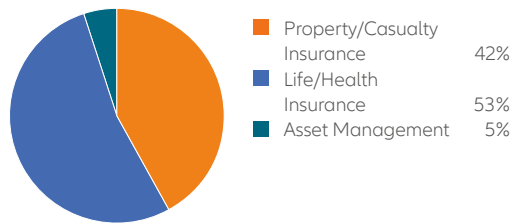
## ABOUT US

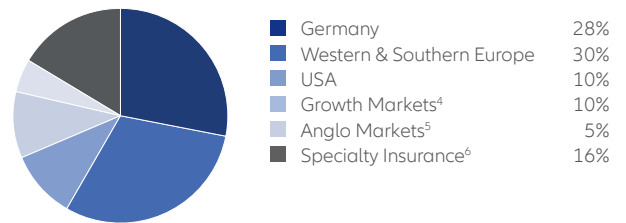

by segments

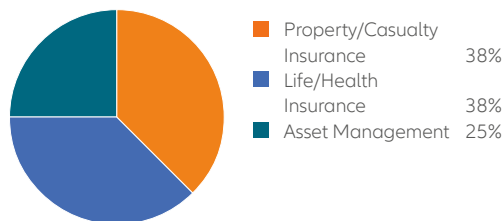


by regions<sup>2,3</sup>

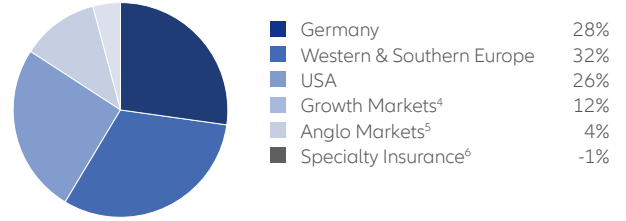


### Operating profit Allianz Group 2020: EUR 10.8 bn

by segments<sup>7</sup>

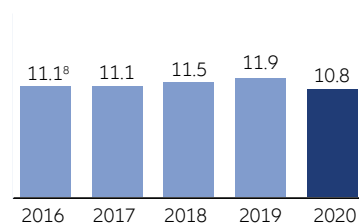


by regions<sup>2</sup>



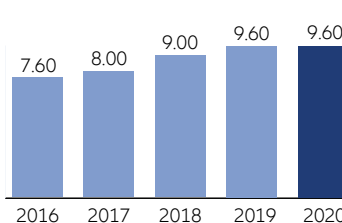
### Operating Profit

EUR bn



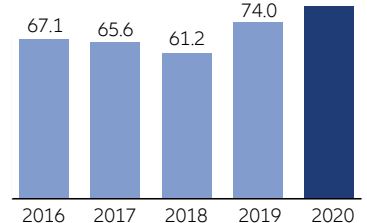
### Dividend per share

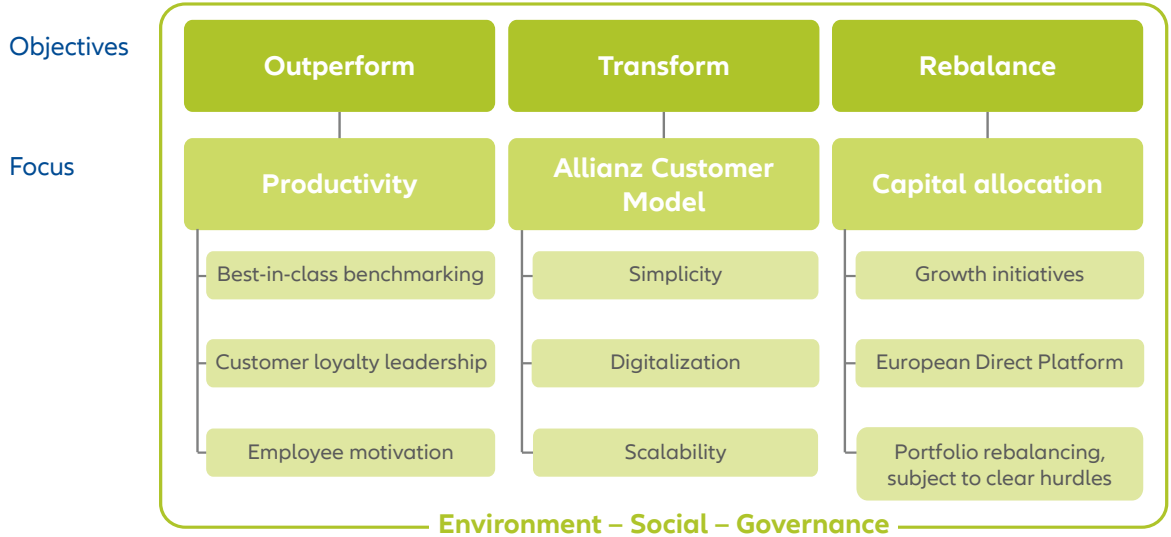

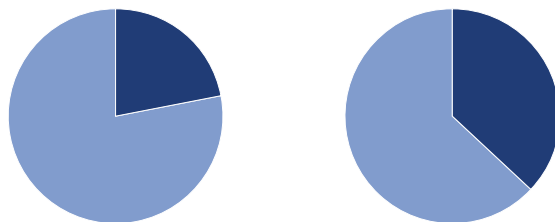

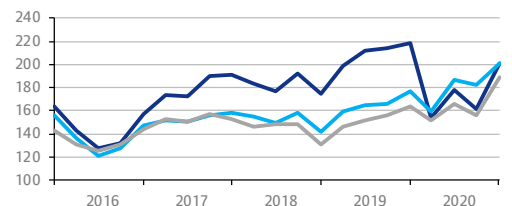
In % of issued capital
