**Total number of shares and voting rights at the time of convening the meeting**

At the time of convening the Annual General Meeting, the Company's share capital is divided into 417,172,859 no-par value shares with participation and voting rights. Of these, 1,810,622 are treasury shares, from which no rights derive for the Company. In addition, due to the limitations set forth in § 3a of the Statutes for registration in the share register in one's own name for shares belonging to another person (so-called "nominee holdings"), 183,125,912 shares are not registered in the share register at the time of convening the meeting and are therefore not entitled to vote. The total number of shares entitled to vote at the time of convocation thus amounts to 232,236,325. The number of shares entitled to vote may still change after the convocation by disclosure and registration of nominee holdings in accordance with § 3a of the Statutes as well as by a change in the number of treasury shares.
