

## Allianz Climate Risk Award 2026



**The annual Allianz Climate Risk Award focuses on excellent research projects regarding resilience, digitalization and weather risks expected to rise as a result of climate change. The global award is funded by Allianz Re, the reinsurance unit of Allianz SE. The thematic award is funded by Allianz Trade and the regional award funded by Allianz Asia-Pacific.**

1. The eligibility requirements are as follows:
  - You are an individual author,
  - You submit only one paper,
  - You are a PhD student or a postdoctoral researcher (eligibility for postdoctoral researchers requires that they have defended their PhD no more than two years prior to the application date),
  - Your research project has advanced beyond the conceptual phase and has attained a certain level of maturity, with anticipated results that are clearly presentable and articulable,
  - If you are selected as a finalist of the global track, you must attend the Allianz Climate Risk Award event in Munich and present your work in person. If you are selected as a finalist of the regional track, you must attend the event in Singapore on October 26<sup>th</sup>, 2026 in person. Allianz Trade reserves rights to hold a virtual event for the thematic award. The winners of thematic and regional awards must attend the Munich event in person and present their research.
2. The deadline for submission is as stated in the call for applications on the official website. Submissions received after this deadline cannot be considered for the Allianz Climate Risk Award. Allianz reserves the right to not consider submissions which are illegible or do not include the complete material.
3. The material submitted will not be returned to senders.
4. The jury will decide which submissions best meet the selection criteria as set out on the website. Decisions made by the jury are final. No correspondence will be entered into.
5. The notification of the finalists and the award winners will be made by email to the addresses specified in the submission. A public announcement will be made on the website.
6. The presentation of the monetary award is subject to the mandatory attendance of the award winners to the Allianz Climate Risk Award events (local, virtual, global) and their presentation during the reserved time slot.
7. Prizes are personal to the award winners and not transferable. The award winners are responsible for the payment of any taxes and charges arising on the prize.
8. Allianz Re / Allianz Trade/ Allianz Asia-Pacific reserve the right to cancel the Allianz Climate Risk Award or one or more of the respective focus awards or vary these Terms & Conditions at any time at its discretion. One or more of the aforementioned Allianz entities reserve the right to suspend the Allianz Climate Risk Award or one or more of the focus awards at any time and to change the form and substance or the specification, dates for deadlines and events.

Allianz Re / Allianz Trade/ Allianz Asia-Pacific reserve the right not to award a winner. Changes are indicated on the website.

9. By entering your submission, you confirm that, to the best of your knowledge, you own all Intellectual Property Rights subsisting in your submission and that it does not infringe any third party's Intellectual Property Rights. You confirm that you have obtained all and any consents, permissions and authorizations that may be necessary in order for you to apply. Allianz Re/ Allianz Trade/ Allianz Asia-Pacific reserve the right to disclose your identity to any third party claiming material posted or uploaded by you constitutes a violation of their Intellectual Property Rights, or their confidentiality/privacy rights.
10. Notwithstanding the foregoing, you grant Allianz Re/ Allianz Trade/ Allianz Asia-Pacific and its affiliated companies a non-exclusive license to use the research submitted only for publication and advertisements purposes of the Allianz Climate Risk Award: by naming the title of the research, your name, affiliation and your contact details. Allianz Re/ Allianz Trade/ Allianz Asia-Pacific may also publish the submitted essay as part of a compendium and/or interviews with you regarding the research project on its website. You agree to the publication of the Allianz Climate Risk Award's results including in particular the publication in the Allianz Climate Risk Award event program.
11. If you are a finalist or award winner, you authorize Allianz Re/ Allianz Trade/ Allianz Asia-Pacific to take pictures during the Allianz Climate Risk Award event and grant Allianz Re without limitation and on a royalty-free basis the right to use including the right to store, copy and distribute printed or digital format photographs related to publications or announcement of the Allianz Climate Risk Award in media publications, online advertisements or in any other format that Allianz Re/ Allianz Trade/ Allianz Asia-Pacific will choose with regard to the Climate Risk Award. 12. Allianz Re/ Allianz Trade/ Allianz Asia-Pacific store and process your personal data in strict compliance with statutory provisions. Your data is collected, stored and processed to conduct the Allianz Climate Risk Award and to carry out follow-up work, which is for the purpose of processing the submission, the selection, as well as for the execution and publication of the Climate Risk Award event and the Allianz Climate Risk Award in general. This involves: your name, your email address, your telephone numbers, the time of online submission in order to prove registration in the event of a dispute.
13. Allianz Re/ Allianz Trade/ Allianz Asia-Pacific confirm that personal data is handled with care and only used for purposes pertaining to the Climate Risk Award. There will be no disclosure of data to third parties beyond this. You can withdraw your consent for the data, email address, and your name to be stored and used at any time without stating reasons.
